Warrants to Purchase 362,479 Shares of Common Stock (and up to 362,479 Shares of Common Stock Issuable Upon Exercise of Such Warrants)

This prospectus supplement, dated August 24, 2022 ("Supplement"), filed by Baudax Bio, Inc. (the "Company"), modifies and supplements certain information contained in the Company's prospectus supplement, dated December 27, 2021 (as amended and supplemented from time to time, the "Prospectus Supplement"), as part of the Company's Form S-3 Registration Statement declared effective by the Securities and Exchange Commission on September 2, 2021. This Supplement is not complete without, and may not be delivered or used except in connection with, the Prospectus Supplement, including all amendments and supplements thereto. The Prospectus Supplement relates to offering of warrants to purchase up to 362,479 shares of our common stock (collectively, the "Warrants") (and the shares of common stock issuable from time to time upon exercise of these warrants) pursuant to the terms of a securities purchase agreement that we entered into on December 27, 2021.

On August 24, 2022, the Company entered into warrant amendment agreements with the holders of the Warrants (the "Amendment") whereby the Company agreed to amend the Warrants held by such holders by reducing the exercise price of the Warrants to \$0.5981 per share of common stock.

Accordingly, this Supplement amends and supplements the Prospectus Supplement to reflect an amendment of the exercise price of the Warrants from \$11.20 per share of common stock to \$0.5981 per share of common stock in accordance with the terms of the Amendment and all references in the Prospectus Supplement to the exercise price with respect to the Warrants are hereby amended and restated to reflect an exercise price of \$0.5981 per share of common stock. Following the Amendment, if all of the amended Warrants are exercised for cash, we would receive gross proceeds of approximately \$0.2 million.

The information in this Supplement modifies and supersedes, in part, the information contained in the Prospectus Supplement. Any information that is modified or superseded in the Prospectus Supplement shall not be deemed to constitute a part of the Prospectus Supplement, except as so modified or superseded by this Supplement. We may further amend or supplement the Prospectus Supplement from time to time by filing additional amendments or supplements. The Company's common stock is traded on the Nasdaq Capital Market under the symbol "BXRX." On August 24, 2022 the closing sale price of the Company's common stock was \$0.5981 per share.
